These guidelines require open communication with all employees, mandate respect for each employee's right to freedom of association and good faith collective bargaining, prohibit discrimination and forced labor of any kind, and require adherence to, and enforcement of, child labor laws. Our equal opportunity, safe and healthy workplaces and other commitments to human rights reflect our belief that the success of our Company is linked with employee satisfaction and well-being. To help ensure that we conduct business according to these principles, we have an extensive list of policies and procedures that define what we expect of our people and our business partners around the world.  To further instill the importance of adhering to Our Credo values in how we engage with stakeholders, employees are required to participate in training on our <a href="#">Code of Business Conduct</a> ("Code") every other year, in addition to affirming that they have read the Code upon joining the Company. The Code and all training is available in 26 languages to better reflect our global, diverse workforce.  Our policies require anti-corruption training for employees who may present a compliance risk to the Company and place a significant emphasis on the training requirements to ensure compliance.
